In order to be eligible for Safalta Education Guarantee program you should fulfill the below requirements, if below terms are not being satisfied you can still be a part of the program and receive the advantages for placement support but you will not be eligible for the Course Fee Refund.

Terms:

The following Terms and Conditions are apply to the Safalta Education – Placement Guarantee Digital Marketing Program

- You must be 18-28 Years and must hold a Bachelor's Degree from an accredited institute.
- You must be proficient in spoken and written English communication.
- You must complete 100% of course curriculum within 6 months of your cohort start date, 80% Attendance is Mandatory.
- You have to qualify all the assignments/projects/tests given to you.
- We will be referring to various companies for interviews if in any case if you fails to attend interview, you will not be eligible for job guaranteed program.
- You must be able to pass any background checks associated with jobs that you apply for with potential employers.
- The Period is defined as 12 Months from the date of start of the program. During this period at any point if you get an offer from any company, it will be considered as a Guaranteed Job.
- A Qualify Person is defined as any Role in the Digital Marketing field as a salaried or waged employee a full time contractor or an intern in a paid internship.
- The 6-month guarantee period starts on the day you are approved for completion, after having completed the above mandatory requirements. During this period: You must be active in your job search and willing to relocate outside your hometown.
- Apply for a minimum of 5 Qualifying Positions per week as shared by the Safalta Placement Department, in accordance with the best practices prescribed by Safalta Education's Mentors.
- You should follow the recommendations for jobs provided by your mentors.
- You must respond to placement-related communications from Safalta Education within 24 hour.
- Safalta Education Placement Team will provide you the job opportunities for 3 months and if you are not able to clear the interview, you have to join the OJT program for 2 months at Safalta Education Office and in between the OJT program you have to appear for the interviews. You must always act with reasonable and good faith efforts to obtain a Qualifying Position.
- Safalta Education will refer the candidates to companies for interviews only with the prior consent of the candidate, in any case, if the candidate is unwilling or fails to attend the interview. Safalta Education will have all the rights to deny any other interview opportunity.
- There should be no pending or registered case against you in any court of law, police or any other government or civic body either in India or any overseas territory.
- These terms and conditions may be modified at any time. The most recent changes or updates will appear on the website.
- Once you are selected by the employer and if you denied to join the organization in case of any reason, it will be considered as a job Offer.
- Indulgence in any negative social media remarks or comments will lead to invalidation of Job Guarantee.
- If you believe you qualify for reimbursement, you must provide a written and signed affidavit that you have met all of the Terms, and have not been offered any Qualifying Positions after the 6 month placement period.

Any provision of these Terms that is unenforceable shall not impact the enforceability of any other provision.
